Guidelines:

1. Contestants must reside in the state of Kentucky and provide proof of residency upon request.
2. Contestants must be 16 years of age on October 31st, but cannot be 22 years of age on October 31st of the current year.
3. The contestant must be a natural born female, single, have never been married, never had a marriage annulled, and never had any children.
4. Previous winners are ineligible to compete.
5. Registration form, birth certificate and Covid-19 waiver must be turned into the pageant committee by midnight Wednesday, July 22, 2020. No entries will be accepted after July 22, 2020.
6. Pageants will follow all state regulations.
7. We are not responsible for lost, stolen, or damaged items.
8. Entry fee of \$50 is due on or before July 22, 2020.
9. Practice is scheduled for Sunday July 26th, 2020 at 3:00 pm at the Griffin Centre.
10. Attire: Appropriate Interview attire, Outfit of choice (Roaring 20's theme), One Piece Swimsuit, and Floor Length Gown.
11. There will be an optional Miss Photogenic title given. This is an additional \$10 entry fee. Please submit a 5 x 7 picture.
12. The winner will be acclaimed and reign as Miss Pendleton County Youth Fair throughout the year and represent the PCYF at the Miss Kentucky County Fair Pageant in January 2021. If unable to fulfill her obligations, the 1st runner-up may assume her duties as decided by the pageant committee.
13. Winners will be expected to participate in all fair activities throughout the week as requested by committee.
14. Winner will not receive monetary awards until all state paperwork is completed and turned into the fair board.
15. Contestants are encouraged to write Thank You notes to sponsors.
16. There will be no soliciting of donations of any kind towards state competition.

17. NO ONE will be PERMITTED backstage except for pageant committee members.
18. Pageant decisions and changes are made by the pageant committee. ALL COMMITTEE AND JUDGES DECISIONS ARE FINAL.

I, _____, hereby acknowledge that I am VOLUNTARILY entering the premises of the Pendleton County Youth Fair Pageants at my own risk, and that I otherwise release, waive, discharge, hold harmless, defend, and indemnify Pendleton County Youth Fair, and it's workers/volunteers from any, and all liability or negligence relating to exposure to, or harm caused by COVID-19. I understand that Pageants carry associated risks due to the inability to ALWAYS maintain social distancing, and to avoid human contact.

I agree to, and verify the following statements:

- Symptoms of COVID-19 include, but are not limited to fever, fatigue, dry cough, and difficulty breathing.
- I, as well as all household members, have NOT experienced any COVID-19 symptoms in the past 14 days.
- I have not been exposed to, it been around, individuals that have experienced COVID-19 symptoms in the last 14 days.
- I, as well as all household members, have not been diagnosed with COVID-19 in the last 30 days.
- I, as well as household members, have not traveled outside of the United States, or to a destination that has been labeled a "hot spot" for COVID-19 within the last 14 days.
- I will follow the guidelines required by Pendleton County Youth Fair Pageants, and understand that is a condition of my entry into the premises.

I understand that the Pendleton County Youth Fair is employing new safety sanitation initiatives, but cannot guarantee that any of these measures will protect me from contracting COVID-19. I also acknowledge that I am free to travel to other pageant events who may not require a waiver, and I am electing to compete at Pendleton County Youth Fair Pageants freely, and voluntarily. I specifically understand and agree to release, discharge, and waive any claims or actions that I may have presently, or in the future for the negligent acts, or other conduct by a member of Pendleton County Youth Fair Pageant and the volunteers/workers producing the event on the premises. Should I pursue any such claim, I shall be obligated to pay all costs, and expenses occurred, including attorney's fees.
