## **Guidelines:**

1. Contestants must reside in the state of Kentucky and provide proof of residency upon request.
2. Contestants must have reached their 5<sup>th</sup> birthday but cannot have reached their 8<sup>th</sup> birthday by June 30, 2020.
3. The contestant must be a full-time student in an accredited Kentucky School System (this includes homeschool).
4. Previous winners are ineligible to compete.
5. We are not responsible for lost, stolen, or damaged items.
6. Pageants will follow all state regulations.
7. All registration forms and birth certificates must be submitted by Wednesday, July 22, 2020.
8. Entry fee of \$25 is due on or before July 22, 2020.
9. We will also have an optional Miss and Mister photogenic (awarded separately) for an additional \$10 entry fee.
10. Contestants need to be at the Griffin Centre by 6:00 PM already dressed.
11. Attire: Sunday best (Easter Outfit) Floor-length dresses are NOT permitted.
12. The winners will be acclaimed and reign as Little Miss and Mister Pendleton County Youth Fair throughout the year. If unable to fulfill their obligations, the 1<sup>st</sup> runner-ups may assume the duties as decided by the pageant committee.
13. Winners will not receive monetary awards until all state paperwork is completed and turned into the fair board.
14. Contestants are encouraged to write Thank You notes to sponsors.
15. There will be no soliciting of donations of any kind towards state competition.
16. NO ONE will be PERMITTED backstage except for pageant committee members.
17. Pageant decisions and changes are made by the pageant committee. ALL COMMITTEE AND JUDGES DECISIONS ARE FINAL. No score cards will be distributed.

I, \_\_\_\_\_, hereby acknowledge that I am VOLUNTARILY entering the premises of the Pendleton County Youth Fair Pageants at my own risk, and that I otherwise release, waive, discharge, hold harmless, defend, and indemnify Pendleton County Youth Fair, and it's workers/volunteers from any, and all liability or negligence relating to exposure to, or harm caused by COVID-19. I understand that Pageants carry associated risks due to the inability to ALWAYS maintain social distancing, and to avoid human contact.

I agree to, and verify the following statements:

- Symptoms of COVID-19 include, but are not limited to fever, fatigue, dry cough, and difficulty breathing.
- I, as well as all household members, have NOT experienced any COVID-19 symptoms in the past 14 days.
- I have not been exposed to, it been around, individuals that have experienced COVID-19 symptoms in the last 14 days.
- I, as well as all household members, have not been diagnosed with COVID-19 in the last 30 days.
- I, as well as household members, have not traveled outside of the United States, or to a destination that has been labeled a "hot spot" for COVID-19 within the last 14 days.
- I will follow the guidelines required by Pendleton County Youth Fair Pageants, and understand that is a condition of my entry into the premises.

I understand that the Pendleton County Youth Fair is employing new safety sanitation initiatives, but cannot guarantee that any of these measures will protect me from contracting COVID-19. I also acknowledge that I am free to travel to other pageant events who may not require a waiver, and I am electing to compete at Pendleton County Youth Fair Pageants freely, and voluntarily. I specifically understand and agree to release, discharge, and waive any claims or actions that I may have presently, or in the future for the negligent acts, or other conduct by a member of Pendleton County Youth Fair Pageant and the volunteers/workers producing the event on the premises. Should I pursue any such claim, I shall be obligated to pay all costs, and expenses occurred, including attorney's fees.
