REVIEW CAREFULLY PRIOR TO SIGNING

I, _____, hereby acknowledge that I am VOLUNTARILY entering the premises of the Pendleton County Youth Fair Pageants at my own risk, and that I otherwise release, waive, discharge, hold harmless, defend, and indemnify Pendleton County Youth Fair, and it's workers/volunteers from any, and all liability or negligence relating to exposure to, or harm caused by COVID-19. I understand that Pageants carry associated risks due to the inability to ALWAYS maintain social distancing, and to avoid human contact.

I agree to, and verify the following statements:

- Symptoms of COVID-19 include, but are not limited to fever, fatigue, dry cough, and difficulty breathing.
- I, as well as all household members, have NOT experienced any COVID-19 symptoms in the past 14 days.
- I have not been exposed to, it been around, individuals that have experienced COVID-19 symptoms in the last 14 days.
- I, as well as all household members, have not been diagnosed with COVID-19 in the last 30 days.
- I, as well as household members, have not traveled outside of the United States, or to a destination that has been labeled a "hot spot" for COVID-19 within the last 14 days.
- I will follow the guidelines required by Pendleton County Youth Fair Pageants, and understand that is a condition of my entry into the premises.

I understand that the Pendleton County Youth Fair is employing new safety sanitation initiatives, but cannot guarantee that any of these measures will protect me from contracting COVID-19. I also acknowledge that I am free to travel to other pageant events who may not require a waiver, and I am electing to compete at Pendleton County Youth Fair Pageants freely, and voluntarily. I specifically understand and agree to release, discharge, and waive any claims or actions that I may have presently, or in the future for the negligent acts, or other conduct by a member of Pendleton County Youth Fair Pageant and the volunteers/workers producing the event on the premises. Should I pursue any such claim, I shall be obligated to pay all costs, and expenses occurred, including attorney's fees.

1. Pageant is open to all Kentucky counties.
2. Baby Miss and Baby Mister Cutie Pie Contestants must be 2 years of age as of July 30, 2020.
3. Tiny Miss and Tiny Mister Cutie Pie Contestants must be 3 years of age as of July 30, 2020.
4. Petite Miss and Petite Mister Cutie Pie Contestants must be 4 years of age as of July 30, 2020.
5. Contestants will need to be accompanied by an adult.
6. Girls and Boys will compete separately.
7. Attire: Girls- swimsuits (one or two piece), Boys – swim trunks, shoes optional. No alternate clothing will be permitted.
8. Winners may not compete again in the same age division, but may compete in the next level upon reaching the required age.
9. Judges will base their decisions on a combination of appearance and personality. Talent and wardrobe will not be a determining factor.
10. Decisions and changes are made by the committee. ALL COMMITTEE AND JUDGES DECISIONS ARE FINAL. No score cards will be distributed.
11. There will be a \$5 entry fee due upon registration.
12. Registration Form and Fee must be submitted by Wednesday, July 22, 2020. We will not accept Registration after July 22, 2020.
